UPP (Cartwright Gardens) Limited CLG Operational Report December 2018



### Purpose

The purpose of this paper is to provide an update to the CLG for the period 4<sup>th</sup> September to 5<sup>th</sup> December 2018.

### **General Operations**

Student Intake took place on 16<sup>th</sup> September, with arrivals staggered for two weeks. An additional security staff presence was put in place, to complete external patrols between 20:00 and 02:00 each evening. This was initially agreed with the CLG for two weeks commencing but was continued for four weeks following a review of complaints and arrival numbers.

The team continue to monitor service road use & feedback to contractors where issues present. The access defects were resolved and the site window clean completed in September without disruption to parking in the vicinity.

The team are proactively logging concerns with the police in relation to anti-social behaviour, response has been limited. There have been six incidents relating to anti-social behaviour within the park, one relating to drug use & the remaining relating to abusive language. All were requested to move on.

### Grounds Maintenance

Routine grounds maintenance continues to be completed by our sub-contractor, visits have been increased for twice weekly during the autumn period to ensure leaves do not become a hazard. The site team are monitoring tennis courts and walkways daily to reduce build up in between visits.

The recommendations of the Tree Survey were carried out in full during November, with impact on surrounding streets minimised through traffic management and close supervision of the works.

Concerns continue relating to hypodermic needle use adjacent to the hut within the park, the planting in this area will be amended to provide less privacy in a further attempt to dissuade users from congregating here. We are reviewing the feasibility of CCTV in this area to be connected to the halls system.

Following review of the Landscape Architect plans by our specialist, the quantities of plants required were detailed and replanting of the beds was instructed and carried out by our contractor in line with requirements. A small number of items will be added in March due to lack of availability from the nursery during this planting season, along with the re-seeding of the grass areas. The paving slab replacement has been instructed and we are awaiting a date for works to be carried out.

## Community Engagement & Sustainability

British Heart Foundation campaign diverted Three Tonnes of waste and generated over £6,000 for the Camden branch of the charity.



Recycling rates are currently 68%, improvements to the signage, bin storage area and communications have been made successful in increasing the uptake. Garden Halls residents undertook sustainability training, ensuring we have champions within the student body to improve awareness of the activities we undertake.

### Feedback

A total of 15 complaints were received from local residents. Ten complaints related to student noise, representing a significant improvement on the same period last year (22). The graph below represents complaint trends for the current academic year.
